This Agreement (hereinafter referred to as the "Agreement") is made and effective this \_\_\_\_\_

by and between \_\_\_\_\_ (hereinafter referred to as the "Purchaser") and South Park Recreation Center (hereinafter referred to as "SPRC")

Now, therefore, Purchaser and SPRC agree as follows:

1. Purchaser agrees to remit payment in full upon signing to:  
South Park Recreation Center, P.O. Box 1075, Fairplay, CO 80440
2. Purchaser agrees to adhere to the following SPRC rules and regulations:
  - Prior to entering the pool all children must receive pool rule orientation by on duty lifeguards.
  - All swimmers must shower before entering the pool
  - All children 5 years and under must be supervised by a person aged 16 or older in the water, and must within arm's reach at all times. **NO EXCEPTIONS!**
  - Children 6-10 years can be in the pool area without parental supervision as long as a parent or guardian aged 16 or older is in the facility and adequate swimming skills have been demonstrated to the lifeguard on duty.
  - Personal floatation devices must be Coast Guard approved and are to be used only with one-on-one supervision from an adult.
  - Children of diaper wearing age must have tight fitting plastic or absorbent pants. No diapers are permitted.
  - Proper swim attire is required. No cut offs or thong bikini's are permitted. T-shirts maybe worn at the discretion of the lifeguard staff.

- No street shoes are permitted in the pool area and must be removed prior to entry.
  - Persons with severe colds, infectious/communicable diseases, open wounds or sores are not allowed in the swimming pool. Bandages and tape are not allowed in the swimming pool.
  - Patrons who appear to be under the influence of alcohol or drugs will not be allowed to utilize the aquatic facility.
  - Rafts, other floatation devices and pool toys such as balls are to be used at the discretion of the lifeguards on duty. Their use will be determined based on pool usage and activities occurring.
  - Food and drink are not permitted on the pool deck, but are allowed in the pool party room.
  - Glass containers are prohibited at all times.
  - The area under the slide and the concrete jetties are off limits at all times.
  - Diving is prohibited in all areas.
  - No running or horseplay on the deck
  - The use of vulgar language or public displays of affection are prohibited.
  - No hanging on the lane/safety lines.
  - Spitting or the chewing of gum is not allowed in the pool area.
  - Sauna users must be at least 16 years old.
  - Patrons must enter and ride the slide in a feet first, face up position. Kneeling, standing, spinning, stopping, or changing position while riding is prohibited.
  - Patrons riding the slide must meet the minimum and maximum height requirement.
  - No floaties or life jackets are permitted.
  - Only one person is allowed to ride the slide at a time. Chains or carrying children in the lap of an adult is not allowed.
  - Sliders must wait until the previous person exists the slide before climbing the steps.
  - No waiting on the steps.
  - Only one person is allowed to catch a child at the bottom of the slide.
  - Balls and other toys are not allowed on the slide.
  - All locker pins or sharp objects must be worn on the front of swimsuits to avoid scratching the surface of the slide.
  - All sliders must exit the splash down area quickly.
3. Either party may cancel contract by written notice to the other party. A full refund, less 25% of total price for processing fee, will be issued for written cancellations.
  4. Under no circumstance will SPRC be liable to Purchaser for any amount greater than the facility usage fee paid by Purchaser. Purchaser will indemnify and hold harmless SPRC for any liability to any party participant arising from use of SPRC material.
  5. This contract constitutes the entire agreement between parties. This contract will be construed under Colorado law and all disputes will be exclusively resolved in courts in Colorado.
